

Delegate - Terms and Conditions

The 2024 First Nations Land and Water Management Forum (the 'Forum') is organised and run by 33 Creative (the 'Organiser') on behalf of the National Indigenous Australians Agency (the 'Host Organiser'). In registering for this Event, you agree to the following delegate terms and conditions.

Please read these delegate (the 'delegate', 'participant', 'you' or 'your') terms and conditions carefully as they contain important information. You acknowledge that you have read and agree to be bound by these conditions by submitting your online registration form, or attending or participating in the event if you are not required to pre-register.

Registration Process:

- By completing the registration form, you agree to abide by all terms and conditions outlined herein.
- All fields marked with an asterisk (*) are mandatory and must be filled accurately.
- Inaccurate or incomplete information may result in the rejection of your registration.
- For the subsidised Full Event Pass (3 Days) ticket priced at \$200 for Indigenous rangers and IPA providers, purchasers must provide a valid Australian Business Number (ABN) during registration.
- The provided ABN will be verified by the event organisers.
- If the purchaser is found to be ineligible for the subsidised ticket price, they will be invoiced for the full General Admissions amount of \$2,000.
- Eligibility for the subsidised ticket price is subject to verification and approval by the event organisers.

Payment:

- Registration fees must be paid in full at the time of registration with credit card being the preferred method of payment.
- Payments are subject to the following fees:
 - \circ Credit Card Fee:
 - Mastercard: 1.25%
 - Visa: 1.65%
- These fees will be added to the total registration amount and will be displayed before the final payment confirmation.
- Payment must be made in Australian Dollars.



- Failure to pay the required fees may result in the rejection of your registration.
- Payment by invoice can be made on request.

Cancellation and Refunds:

- Requests for cancelation and refunds must be made in writing to <u>events@33creative.com.au</u> up until **15 July 2024**.
- Cancellations made before this deadline will be eligible for a refund.
- After 15 July 2024, tickets are non-refundable, except in cases where the event is cancelled by the organisers.

Attendance:

- Your registration may be transferable on request up to 2 weeks before the Forum and requests for transfer must be made in writing to events@33creative.com.au by **12 August 2024**
- Lanyards provided by the organisers must be worn at all times during the event.
- Unauthorised sharing of lanyards to the Forum is strictly prohibited.

Code of Conduct:

- All attendees are expected to conduct themselves in a respectful and professional manner.
- Discriminatory, harassing, or otherwise inappropriate behaviour will not be tolerated and may result in expulsion from the event without refund.
- The organisers reserve the right to refuse admission or eject any attendee violating this code of conduct.


Liability:

- Attendees who opt out of photography and videography on registration will be given a special lanyard indicating their preference.
- Attendees wearing the special lanyard will not be included in any photography or videography during the event.

Changes to the Event:

- The organisers reserve the right to make changes to the event schedule, speakers, venue, or any other aspect without prior notice.
- In the event of a significant change, reasonable efforts will be made to notify registered attendees.

Force Majeure:

• The organisers will not be liable for any failure or delay in performance resulting from causes beyond their reasonable control, including but not limited to acts of nature, government restrictions, and labour disputes.

Privacy and data processing consent

• The Organiser operates a strict privacy policy and is committed to protecting the privacy of its delegates. During the registration process, the Organiser will gather and record personal information necessary for your attendance and for future communication purposes. All personal information is gathered, stored, and disseminated in accordance with the National Privacy Principles (NPPs) as set out in the Privacy Act 1988 (as amended).

Data Storage

Our data is stored securely on an Australian server by EventsAir. We will use collected data solely for forum-related purposes, such as sending registration confirmations, event updates, and post-forum surveys.

We will retain delegate data only for the duration of the Forum and any necessary postforum follow-up activities.

Governing Law:

- These terms and conditions shall be governed by and construed in accordance with the laws of the state of New South Wales.
- Any disputes arising under these terms and conditions shall be subject to the exclusive jurisdiction of the courts of its courts.
