

Conditions of Entry – Bective Station

Entry to Cattle Australia Cattle Connect 2024 ("Event") at Bective Station on 21 November 2024 is subject to the following Conditions of Entry ("Conditions"). By entering Bective Station you acknowledge that you have read and irrevocably accept these Conditions. If you do not accept these Conditions, entry is not permitted to the Event.

Bective Station Pty Ltd ACN 001 067 545, Bective Operations Pty Ltd ACN 661 988 236, Agricultural Asset Management Pty Ltd ACN 151 285 906 and each of their related entities, including their respective directors, officers, employees, agents or representatives ("**Operators**") permit entry to Bective Station and participation in the Event on the basis of the following:

1.1. Conditions

Any person who attends the Event at Bective Station agrees to:

- comply with rules, policies, notices, biosecurity measures, signs or other directions issued by the Operators at all times;
- remain within the cordoned or allocated Event areas and public walkways; not enter any other restricted or no entry areas at Bective Station;
- ensure children under the age of 16 years are supervised by a responsible adult at all times;
- ensure that no firearms, knives, blunt objects, flammable items, alcohol or illicit drugs, or other prohibited items are brought into the Event;
- take reasonable caution at all times when viewing livestock, machinery and other trade site areas;
- (if working or contracted at Bective Station, including trade stall staff) complete the site-specific induction for work, health, and safety purposes and carry a completion certificate at all times.

1.2. Safety and Emergencies

Any person who attends the Event at Bective Station must:

- immediately report any hazards, accidents, injuries sustained, emergencies, incidents and near misses to the first aid tent;
- wear appropriate footwear and other personal protective equipment where required or directed;
- in the event of an emergency or if an evacuation is required, use the safest route to calmly move to the signposted emergency assembly point and await further instructions from Cattle Australia staff, the Operators or emergency services.

1.3. Refusal of entry or eviction

The Operators reserve the right, in its absolute sole discretion, to refuse entry or evict any person or persons from Bective Station and the Event who:

- is or becomes intoxicated or appears affected by a prohibited substance;
- is disorderly or a public nuisance;
- behaves in a manner that may cause injury to themselves, the Operators or its property, or other persons who are at the Event;
- does not comply with these Conditions.



1.4. CCTV and photography notice

The Operators use photography, video, and other CCTV technology for media, marketing, live streaming, surveillance, and other promotional activity. You consent to being photographed or videoed at the Event for this purpose.

1.5. Biosecurity

Biosecurity measures are crucial to protect our animals from diseases and maintaining a healthy farm environment. If you have travelled overseas in the past 7 days, entry into the Event at Bective Station is not permitted unless otherwise communicated in writing.

1.6. Liability waiver

To the maximum extent permitted at law, any person who attends the Event agrees to waive the right to take any legal action against the Operator for any loss, damage, claim or demand arising from any physical, mental, or other injury (including death), suffered by a person or a person in the care or control of another person, and indemnifies the Operator against all liabilities, claims, actions, demands, proceedings, tort, losses, costs and expenses suffered or incurred by a person in any way connected to the Event or entry onto Bective Station.

1.7. Acknowledgments

Any person attending the Event acknowledges to the Operator that:

- entry into the Event at Bective Station is voluntary and at the that persons own risk at all times;
- responsibility for personal possessions remain with that person at all times;
- they are physically able participate in the Event, and do not suffer from any pre-existing medical conditions, or take any medications that may affect a person's capacity;
- in the event of a safety matter, injury, or emergency, the Operator may provide evacuation, first aid, or medical treatment at the expense of that person;
- the Operators are not responsible for maintaining accident insurance, public liability insurance, or ambulance cover over any person attending the Event;
- the purpose of these Conditions is to exclude all liability of the Operators for any loss, death or injury which has been caused or contributed to by any activity at the Event and this release will forever bind any person including their heirs, successors, executors, personal representatives, and assigns.
