

Abstract Guidelines

Abstract submission opens: 23 August 2024

Closing date for the receipt of abstracts: 15 December 2024

If you would like to be on the program for the MJD International Research Conference, providing an abstract is the first step.

For the Darwin Conference we are keener than ever to focus on *Bridging Science and Service:* Research in Culturally Responsive Ataxia Healthcare

The 2025 conference aims to foster collaboration among researchers and clinicians in the ataxia community, particularly those focusing on Spinocerebellar ataxias, to exchange invaluable insights, advancements, innovations, and drive breakthroughs in treatment and access to care for individuals affected by MJD, as well as their families and communities.

Abstract categories, topics and assessment criteria

Abstracts are sought in the following **categories**:

'Research' - previously unpublished or recently published research reports, using quantitative and/or qualitative methods;

- Clinical Research and Trial Readiness
- Basic and Preclinical Research

'Service' - practical reports of projects on the ground and models of innovative and successful service delivery;

Living with Ataxia - Clinical Care and Quality of Life

Attachment A includes a list of potential **topics**, provided to illustrate some of the current priority areas abstracts and papers might cover.

The assessment criteria that will be used to select abstracts are also listed in Attachment A.

Types of presentations for which abstracts can be submitted

For each abstract, authors are asked to indicate the type of presentation for which it is submitted, from the following options:

Oral presentation 20 minutes. Full paper to be published in Conference Proceedings (see Note on publication below).

Fire Talk 10 minutes. Full paper to be published in Conference Proceedings (see Note on publication below).

A poster presentation

Author to be available during poster sessions to enter into dialogue with viewers about the poster's content. Where possible, an electronic version of the poster (pdf, jpg) will be published in Conference Proceedings; if not available electronically, the submitted abstract will be published.

Following a review process by the Scientific Committee, authors will be contacted about the status of their abstract. Successful authors may be offered the presentation type of their choice or they may be offered a spot in a workshop, or as a poster presentation.

Note on publication: With the exception of authors who want to submit their papers after the Conference for publication elsewhere, all presenters will be required to provide their full paper for inclusion in the Conference Proceedings. Authors subject to the exception will be required to prepare a one-page summary of their presentation for the Conference Proceedings.

Conditions relating to abstracts

- Abstracts should relate to previously unpublished or recently published papers, so that all
 papers presented at the conference will be original.
- Abstracts should be **no more than 400 words** and should be uploaded as a word document.
- Authors may submit more than one abstract.
- Submitting one or more abstract is **no guarantee** of a spot on the Conference program.
- Assistance with the presentation of an abstract is available to all who seek it, and is particularly
 offered to first-time presenters. Wherever appropriate, assistance will also be offered with full
 papers and presentations. For further information, contact

Format of abstracts

- An abstract should summarise the important points of the proposed presentation and highlight the original content to be communicated. It needs to be concise but informative, containing an outline of the aims, methods, relevance, results and conclusions of the work undertaken.
- Abstracts should be uploaded as word documents (<u>DOWNLOAD TEMPLATE HERE</u>).
- Abstracts should be no longer than 400 words and should not include tables, figures or references.
- Abstract titles should be no more than 12 words.
- The file name of the document to be uploaded should be the **same title** as is on your abstract.
- Include authors names and details

Submission methods

- Abstracts should be submitted online through the Conference Website
- Authors who are not able to submit their abstract online are asked to contact mjdf2025@associatedadvertising.com.au

Successful abstracts

Authors of successful abstracts will be offered a spot on the Conference program. Assuming that you accept the offer:

- You must register for the Conference;
- you will be sent paper guidelines and a timeline for the preparation of your full paper (Attachment B);
- you will be asked to provide a short speaker's biography for inclusion in the Conference Handbook; and
- your place on the program will be confirmed when your full paper and registration is received.
- All presented papers will be included in the Conference Proceedings, which will be published and
 on the MJDF website. In cases in which the paper is to be offered for publication elsewhere, a
 one-page summary of the presentation will be required for inclusion in the Proceedings.

Criteria for the assessment of abstracts

The criteria used by the Scientific Committee in selecting abstracts will be as follows:

Current and relevant: the presentation will have an emphasis on and/or relevance to Spinocerebellar ataxias and Innovations in Culturally Responsive Ataxia Healthcare.

Analytical: the presentation will provide more than a description of a program or a service; it will draw out insights, what was learned, recommend new policy and/or actions.

New knowledge: it will provide new ideas or develop further what we already know or have shared previously.

Conference theme and topics: it will offer something unique and/or required relating to the Conference theme.

Broadening health: it will promote understanding of the range of factors and disciplines that impact on the health and wellbeing of individuals affected by MJD, as well as their families and communities.

Quality: it is of high quality scientifically and/or in other ways.
