The Compass Conference is Northern Territory PHN and Rural Workforce Agency NT's premier professional development and networking event for primary health care professionals and will take place at the Darwin Convention Centre from 12 to 13 August 2022.

The theme for this year's conference is 'Navigating the way forward'. After a tumultuous 2020, it's time to look forward and celebrate the resilience of our primary health care workforce and focus on wellbeing, as well as our learnings from the past year and the opportunities it has created.

At Compass 2022 we will delve into these factors and explore practical applications o preventative health measures to promote the best health outcomes for Territorians. Of course, we can't achieve this without a healthy and resilient primary health care workforce, and practitioner wellbeing and contemporary wellbeing practices will be a key focus throughout the conference.

Conference attendance is growing year on year. In 2019, more than 400 delegates attended over the two days, an increase of 100 attendees from the previous year. Delegates will again include a broad range of primary health care professionals including general practitioners, nurses, allied health professionals and Aboriginal health workers from all regions of the Northern Territory.

Development of this year's program is well underway, with a focus on lessons learnt and opportunities created through the COVID-19 Pandemic.

In addition to a strong professional development program, the conference presents excellent networking opportunities through trade displays and exhibition booths. The Gala dinner on the Friday evening features the Northern Territory Health Professional of the Year Awards and is an opportunity to celebrate our peers and network with all delegates.
