




What role(s) do you perform in your training practice? (select one)






How long have you been a fellowed General Practitioner? (select one)






How long have you been a GP Supervisor? (select one)
















In which State or Territory of Australia is the practice in which you spend most time training located? (select one)












Are Rural Supervisors more satisfied than their Urban counterparts?








My RTO provides sufficient professional development opportunities to support me in my role as a GP Supervisor






My RTO provides adequate resources for my role as a GP Supervisor






My RTO supports me in my role as a GP Supervisor






My RTO provides a Supervisor Liaison Officer






My practice has a positive relationship with my RTO






GP Supervisor remuneration should be standardised across the industry






What could your RTO do to support you better in your role as a GP supervisor? (select one or more)






How would you rate your overall level of satisfaction with your RTO?






What do you think are the key issues requiring GPSA advocacy (select one or more)








