

# AIFLAM – Chair's Report 2021 AGM 29 November 2021

#### **AIFLAM Board and Secretariat**

The AIFLAM Board has met on 4 occasions since the last AGM.

Specialist Board committees (established in 2020 for Arbitration, Mediation and Members Services together with an Executive Committee comprising the Chair, Deputy Chair, Treasurer and Executive Director) have also met on numerous occasions throughout 2021.

Our Board and Secretariat structure consisting of an Executive Director, supported by a Member Services and Events Coordinator, enables us to quickly respond and support members in their family law practices. Further improvements are planned in 2022 for the EventsAIR platform that supports our website and management of our courses.

#### 2021 AIFLAM Board election

Pursuant to the AIFLAM Constitution an election for members of the Board was held during October and early November 2021.

I would like to take this opportunity to record our sincere gratitude and appreciation to the following Board members whose terms on the Board have ended for various reasons:

- The Hon Justice Strickland his Honour has been the Family Court of Australia appointee to the AIFLAM Board since 1999 and was the Family Law Section appointee in 1998. With his retirement from the Court on 20 November 2021, his appointment to the Board also ceased on that date. His Honour has made a tremendous contribution to AIFLAM during his lengthy time on the Board, including as a regular presenter in our arbitration courses, and more recently as Chair of the Arbitration Committee. We are very grateful to his Honour for agreeing to stay on as Chair of the Arbitration Committee post his retirement from the Court.
- Judge Turnbull Marcus Turnbull SC, formerly AIFLAM Treasurer, retired from the Board
  on his appointment as a Judge of Federal Circuit Court of Australia, now the Federal
  Circuit and Family Court of Australia, in May 2021. Judge Turnbull was the elected
  Tasmanian representative from 2014 and also represented the Family Law Section of the
  Law Council of Australia. Judge Turnbull continues to provide valuable support to
  AIFLAM, and will assist with facilitation of the specialised mediation training in Hobart in
  2022.

I am also very grateful for the commitment and dedication of other board members and senior AIFLAM practitioner members who assist with delivery of our courses. This enables us to provide the best family law focused arbitration and mediation training in Australia.

Training programs delivered in 2021 online via Zoom included:

3 November - NMAS Re-accreditation Day

22-26 November - Mediation Training Course (NMAS Accreditation)

We have also held state based local CPD events combined with Christmas celebrations and networking in WA and SA.

We are still finalizing our program of courses for 2022 and hope to offer a combination of face to face and zoom delivery options.

At this stage, the next Arbitration Training Course will be held immediately prior to the Family Law Section National Family Law Conference in Adelaide and is open for registration. The course will run on 25-26 March 2022.

## Representing the Family Law Profession in Arbitration and Mediation

## Review of the National Mediation Accreditation System (NMAS)

A review of the NMAS was commenced at the end of 2020 and has continued throughout 2021. Resolution Resources were engaged by the Mediator Standards Board to facilitate the review. AIFLAM has participated in all aspects of the review to date, including workshops and reference groups. I will keep members updated as to the progress of the review via our regular newsletters.

## **AIFLAM Complaints Process**

Early in 2021 the complaints process provided by AIFLAM to our members was updated and approved by the Attorney-General's Department. The complaints process also extends to all our members who are FDR practitioners, enabling them to comply with the requirement of the Attorney-General's Department to nominate a complaints handling body, to maintain their registration as an FDRP.

## Support for Arbitrators and Mediators in the Courts

The Institute has continued to support the courts with the provision of lists of our members who are NMAS Accredited Mediators, and Regulation 67B Arbitrators. We are very grateful for the support of the Hon William Alstergren, Chief Justice of the Federal Circuit and Family Court of Australia for his ongoing preparedness to collaborate with AIFLAM in relation to mediation and arbitration as a means of resolving family law disputes.

As the holder of the national list of trained and qualified Regulation 67B family law arbitrators in Australia, AIFLAM is well placed to assist and support members in their practice as an arbitrator, or as a practitioner referring matters to arbitration. In addition to the List of Arbitrators, our website also provides a range of valuable resources including the

Arbitration Standards and Guidelines and a kit with background information, agreements and orders. If agreement cannot be reached about who should be appointed to arbitrate, I am able, in my capacity as Chair of AIFLAM, to either nominate a suitable Arbitrator or pick one from a list submitted by the parties.

#### **AIFLAM Website and Member Portal**

The AIFLAM website provides access to practitioners and members of the community generally, who are searching for a mediator, arbitrator, or family dispute resolution practitioner. The search is geographically based and includes the option to search for a fixed fee mediator. We have recently further upgraded the home page of the website to ensure that the search facility is easy to locate and use.

It is therefore important that your details are kept up to date in the member portal, and I strongly encourage you to login and check. In particular, please ensure that you have confirmed your NMAS accreditation, so that you can be included on the lists provided to the courts, and on our website. There is also the option in the member portal to indicate whether you are prepared to accept instructions for fixed fee mediations in family dispute matters with a low asset pool, and to indicate if AIFLAM is your nominated complaints body for FDRP.

## **AIFLAM Membership - Categories of Membership**

In 2021 the AIFLAM Board resolved to introduce some additional categories of membership:

- Student membership is now available free of charge.
- Junior membership is now available at a reduced rate for practitioners with 0-4 years PAE. Practitioners working in legal aid, community legal centres and not for profit organisations are also able to access this reduced rate.

The Board also resolved to appoint Life Members and award annual Honorary Memberships, as it is able to do pursuant to the AIFLAM Constitution, as updated in 2020.
