Maximising Partnerships Between Research and Advancement To Increase Funding

As research institutions plan for the future there is a need to diversify grant funding in an increasingly competitive environment. At the same time philanthropists, foundations and granting bodies are looking to collaborative models within and between institutions to maximise their research funding and create greater research impact. Research Offices and Advancement Offices are both engaged in attracting research funding into institutions. Although traditionally the two offices have operated independently, the changing landscape highlights the need for these offices to collaborate better to diversify and increase funding.

The **Australasian Research Management Society (ARMS)** and the **Council for the Advancement and Support of Education (CASE)** are jointly hosting a two-day workshop detailing how Research Offices and Advancement Offices can effectively work together to increase funding for research and development.
