#### REGISTRATION CONDITIONS

### 1. Contract and price

Cancellations, amendments and substitutions must be made in writing to The Association Specialists to conference@aitd.com.au

The following terms will apply to any notice of cancellation of attendance at the Conference received:

- Up to 6 June 2023: full registration fees will be refunded minus an administration fee of \$100.
- From 7 June 2023 to the conference: no refunds will item(s) cancelled, substitutions only

#### Any cancellations from 7 June 2023 up to the conference will be liable for the full cost.

We do understand that circumstances change and we will consider cancellations on a case-by-case scenario. At any point prior to the Conference you are welcome to contact us in writing to nominate a substitute delegate at no extra charge.

#### 5. COVID-19 Cancellation Policy

# 5.1 What happens to my registration if AITD cancels the conference due to government restrictions?

#### 5.2 What happens to my registration if the Conference shifts from face to face to fully virtual?

All attendees will automatically be transferred to a virtual registration, and any difference in fees will be refunded.

In the event the Conference is postponed, all registrations will automatically be transferred to the new Conference dates.
