## The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference Terms and Conditions

These terms and conditions (“T&Cs”) form part of your online registration (“Online Registration”) for The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference. By completing and submitting your Online Registration and ticking the relevant box as part of the registration process, you agree to be bound by these T&Cs.

### **1. The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference**

1.1. You are responsible for ensuring you have the appropriate facilities, equipment and internet connectivity to access The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference.

1.2. You must always behave in a professional and appropriate manner at our event and must not engage in any behaviour contrary to this. This includes, but is not limited to, trying to exhibit without registering as an exhibitor or sponsor, marketing your business without registering as an exhibitor or sponsor, bad behaviour or protest.

1.3. During the course of The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference, you may not: (i) perform any activity or cause or permit anything that is reasonably likely to be disruptive or dangerous to AASW, any exhibitor, sponsor, or any other delegates or attendees; or (ii) conduct or pursue any illegal or offensive activities.

1.4. Unless you have registered as a sponsor or exhibitor, you may not sell or display any goods or services or distribute any materials at The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference.

1.5. We reserve the right to deny access, or require a person already admitted, to leave The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference without refund, liability, or compensation should the attendance of such individual be determined illegal, disruptive, inappropriate or potentially a legal or reputational liability, or inconsistent with these T&Cs. Furthermore, we reserve the right to require an individual to leave The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference at any time for any reason or no reason, in our sole and absolute discretion.

### **2. Payment of the Registration Fee**

2.1. This clause 2 only applies where a registration fee for attending The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference is indicated as part of your Online Registration (“Registration Fee”).

2.2. You agree to pay the Registration Fee as detailed in your Online Registration and in accordance with these T&Cs. The Registration Fee, unless otherwise stated, is inclusive of all charges, duties, taxes or similar charges.

2.3. You agree that you must be a valid member of AASW in order to access the member registration rate. If you provide any false information, you will be required to pay the full non-member fee, or otherwise your registration will be cancelled.

2.4. If you wish to upgrade your registration from a 1-day ticket, to a 2-day ticket, you must contact the organisers (Forum Group Events & Marketing) and pay the difference to have this arranged.

2.5. You will not be able to downgrade your registration from a 2-day ticket to a 1-day ticket and no refunds will be issued.

2.6. Where you have completed an Online Registration, you must make immediate payment via credit card in the "Payment" section of the Online Registration before submitting your registration.

### **3. Cancellation/Postponement**

3.1. All bookings are non-cancellable, and any Registration Fees paid are non-refundable.

3.2. In the unlikely event that we have to cancel The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference, if, for example, delegate numbers are too low to run the event, we will give you as much notice as possible, and you will be given the option of a refund or transfer to an alternative event.

### **4. Non-attendance**

We are not liable to you for any non-attendance for any reason. If you are unable to attend The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference, event presentations will be available after the conference. Please consult the Event website or contact us for further details.

### **5. Circumstances outside our control**

We will not be liable to you for any delay, defect or deficiency in performing our obligations under these T&Cs to the extent that such delay, defect or deficiency is caused by an event beyond our reasonable control. This includes (but is not limited to) acts, defaults or omissions of our suppliers or subcontractors, unavailability of The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference platform, a strike, lock out or other form of industrial action, outbreak of hostilities, riot, civil disturbance or acts of terrorism; pandemic, epidemic or other health emergency; fire, explosion or flood; or theft and malicious damage.

### **6. Program changes**

We will use reasonable endeavours to avoid changes in the advertised program for The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference. However, from time-to-time, amendments may be required, for example, as a result of changes to speakers' circumstances or corporate change. It is your responsibility to check the status of The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference program.

### **8. Data protection**

8.1. We will process the personal data you provide in your Online Registration in accordance with our Privacy Policy.

8.2. You understand that by choosing to attend The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference, you have the option to provide exhibitors or sponsors with your personal data (as disclosed when registering). With your consent, your personal data will be transferred to an exhibitor or sponsor, and they may contact you about their products or services. On disclosure of your personal data, the exhibitor or sponsor becomes the data controller of that personal data and is responsible for compliance with relevant data protection laws.

### **9. Photography and Social Media**

9.1. You must not take photographs or otherwise record or reproduce content from The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference or of any presentations without AASW's written approval.

9.2. You may not tag or otherwise discuss on any social media platforms any person at The 26<sup>th</sup> Asia-Pacific Regional Social Work Conference without their permission.
