By completing your registration and thereby agreeing to our Terms and Conditions you agree to be bound by these T&Cs.

Your agreement with us

All attendees who register for the event should read the T&Cs carefully, these terms govern your online and in person registration, online and in person attendance at and/or participation in the hybrid event. By registering to the ICSWHMW you agree that you have read and accepted the T&Cs and agree to be bound by the T&Cs. Should you not wish to be bound by these terms, please do not register, attend or participate in the hybrid event.

Registrations on behalf of another

If you are registering on behalf of another person, it is your obligation and responsibility to make sure that the person attending is aware of the T&Cs and accepts them. By completing the registration, you are submitting that the person you are representing has warranted that they are aware of these terms and that they have accepted the T&Cs.

1. Registrations

1.3. Registration balances must be paid for registrations to be confirmed and submitted.

2. Payment of Registration Fees (if applicable)

- 2.1. This clause 2 only applies where a registration fee for attending the event is indicated as part of your Registration (“Online Registration Fee”, “In Person Registration Fee”).
- 2.2. You agree to pay the Registration Fee as detailed in your Registration (“Online Registration Fee”, “In Person Registration Fee”) and in accordance with these T&Cs. The Registration Fee, unless otherwise stated, is inclusive of all charges, duties, taxes or similar charges.
- 2.3. You agree that if you are accessing a discounted *AASW Member* fee that you are a valid member of the Association. If you provide false information, you will be required to pay the difference between what you register for, and your correct membership category registration cost, or otherwise your registration will be cancelled.
- 2.4. The *Student* registration fee category is open to both Australian and international social work students. Australian students need to be enrolled in a Bachelor of Social Work or Master of Social Work. International students need to be enrolled in a course comparable to an Australian Bachelor or a Master of Social Work. Please note that PhD students are not eligible for this fee category. To register under the student category, attendees will be required to upload a copy of their student ID for verification purposes. If you provide false information, you will be required to pay the difference between what you register for, and your correct membership category registration cost, or otherwise your registration will be cancelled.
- 2.5. Payment must be made immediately via credit card in the “Payment” section of the registration before submitting your registration.

3. The Event

- 3.1. You are responsible for ensuring that you have (i) suitable footwear and clothing for the conference, we encourage you to dress smart casual (ii) and that you have the appropriate facilities and internet connectivity to access the event.
- 3.2. You must always behave in a professional and appropriate manner at the event and must not engage in any behaviour contrary to this. This includes, but is not limited to, trying to advertise products or services, marketing your business or bad behaviour or protest.
- 3.3. inconsistent with these T&Cs. Furthermore, we reserve the right to remove an individual to the hybrid event at any time for any reason or no reason, in our sole and absolute discretion.

- 3.6. In-person registrations agree to comply with reasonable instructions issued by the 10th ICSWHMH, AASW or the operator of the venue for the event.
- 3.7.
