## Booth inclusions

All booths come with two All-Access passes. These passes provide access to the Trade Show during opening hours. Passes will not be required to access bump-in and out.

Catering at Hort Connections will be subject to COVID-19 restrictions and guidelines. Exhibitors will be notified of any significant changes once they have been confirmed.

Additional exhibitor Trade Show passes can be purchased for \$250 (AUD) incl. GST up to midnight on June 6 (after this date exhibitor passes will need to be purchased at the regular delegate rate). The Exhibitor Pass provides access to all Trade Show events, and includes complimentary Wednesday speaker session access. Exhibitors are also eligible to receive the discounted member-only rate on All Access passes, providing access to all events on the Hort Connections 2022 program.



# TERMS AND CONDITIONS

## Things you need to know

The following terms and conditions apply to your booking to exhibit at Hort Connections 2022:

- You (exhibiting organisation) complete all steps in the Exhibitor Portal and 'accept' these terms and conditions.
- We/Us (AUSVEG and PMA A-NZ) representing the local organising committee and the host body do not accept responsibility for any errors, omissions or changes.
- Details may change without notice.
- Please refer to the event website for the latest information.

## Financial facts

- All prices are quoted in Australian Dollars and include 10% GST.
- Phone or unpaid bookings will not be accepted.
- We will issue a tax invoice which is payable within 14 days.
- If you miss the payment date, any time dependent discounts will be forfeited—you may be billed at the next highest level (early rate to standard etc.).
- If payment is not received within 30 days, your selected booth and preference will be forfeited—you will be able to select your booth from those available at the time payment is received.
- You will not receive any exhibition entitlements, including allocation of booth location (allocated to sponsors first and then to exhibitors), until all monies have been paid.
- If you pay by electronic funds transfer or an international cheque you agree to pay any bank charges and must include these in the amount you transfer.
- If you pay via credit card, a merchant fee may be charged if detailed on the application form. Debits to your credit card, except for accommodation, will appear as AUSVEG LTD GLEN IRIS AU on your statement.

## If you need to cancel

- You must notify us in writing if you need to cancel.
- Cancellations made before 28 February 2022 will be refunded less 50% of the total purchase price.
- Cancellations made after 28 February 2022 will not be refunded.
- Your non-payment does not cancel your contractual obligations to us. This may be enforced if the terms and conditions have not been adhered to.

## Unlikely cancellation of the event

- The extent of refunds will be a matter for the host organisation (the underwriter) to decide.
- We have no responsibility for making refunds and attempts to cancel cheques or credit card payments will be rejected by our bank.
- If the event is postponed due to COVID-19, exhibitors will be offered the option of rolling over their investment to the 2022 event, or a full refund.
- The exception to this is if there is a COVID-19 related reason for event cancellation

## You and your staff - onsite

- Your exhibition booking does not constitute an attendee registration. You will need to do this via the exhibitor portal, or via a relevant form supplied.
- All exhibition staff must be registered via the Exhibitor Portal by redeeming complimentary registrations or by purchasing additional exhibitor staff registrations.

## Print entitlements

- Logos and/or company names will be reproduced in the event colour/s, full colour, or mono, at our discretion. All logos must be at least in JPEG or PNG format, and without a transparent background.
- No print or web recognition will be given unless payment terms have been met.

## Things you need to know

- Booth preferences are considered 'reserved' until confirmed by the organisers, AUSVEG and/or PMA A-NZ.
- Floor plan updates are made in real time, with available booths changing frequently.
- Booth preferences submitted via the portal will be honoured as long as the payment terms have been met.
- Booth preferences will be held for 30 days from the time of application. If payment is not received by this time, the booth preference will be released and available for sale.
- Exhibitors will then have their initially booked booth confirmed once payment has been received and/or remittance provided.

## Privacy statement

- Event organisers, AUSVEG and PMA A-NZ are required to collect contact details of all registered delegates to communicate all relevant event information.
