Our focus is on supporting you with your event logistics, providing advice and assistance at every step of the journey to help ensure the success of your show.



ADVANCE WAREHOUSE COURIER DEADLINES & DELIVERY ADDRESS

As the official freight handling agent, we discourage the use of courier companies for high value shipments as they cannot be cleared as temporary admission into Australia – If you do choose to proceed via courier – for small shipments with minimum values please note it is the sender's responsibility to ensure the chosen courier provider is able to clear and deliver to our advance warehouse with all charges prepaid.

- All Items must be clearly labelled with exhibitor name and stand number details please feel free to use the attached label template
- Due to increased security requirements please note, shipments arriving without prior pre alert, or outstanding duty and tax payments may be refused / won't be accepted from our end.
- All Handling charges must be settled prior to freight being handed over / delivered to your exhibition stand at the show there are no credit terms for advance warehouse services applied for

SENDING COURIER SHIPMENTS DIRECT TO THE SHOW SITE


We strongly recommend refraining from consigning any courier shipments to be delivered directly to your stand at the show venue – the risk of delays in delivery or misplacing of your items is extremely high during the build-up period. If you decide to send your exhibition materials directly to the venue, please note neither the event organiser or GEL Events / Gaffney's Pty Ltd will be able to confirm receipt / sign for your delivery as we are unable to accept any liability for courier shipments not routed via our dedicated advance warehouse service. Please note if you engage the service of a courier company – and issues arise with the customs clearance once arrived into Australia, we can try to assist, interfering with the clearance will be chargeable as per our airfreight tariff but the main issue remains the timely release from the authorities. Please feel free to contact us prior to sending any courier shipments to Australia so that we can support you with the pre planning and could also propose alternative services to guarantee your exhibition material arrives safe and in time for the event.
