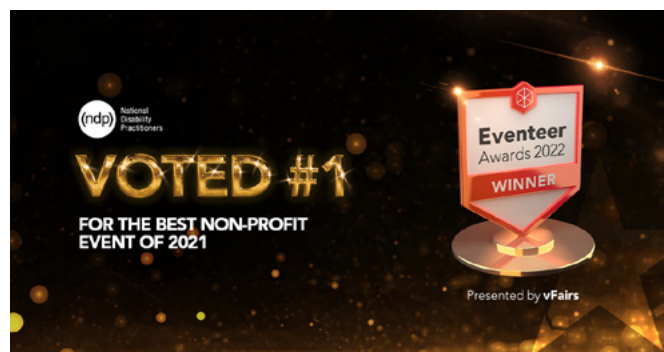
## About NDP

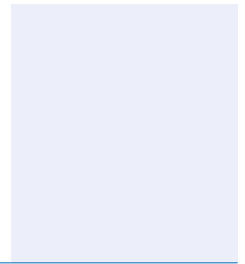

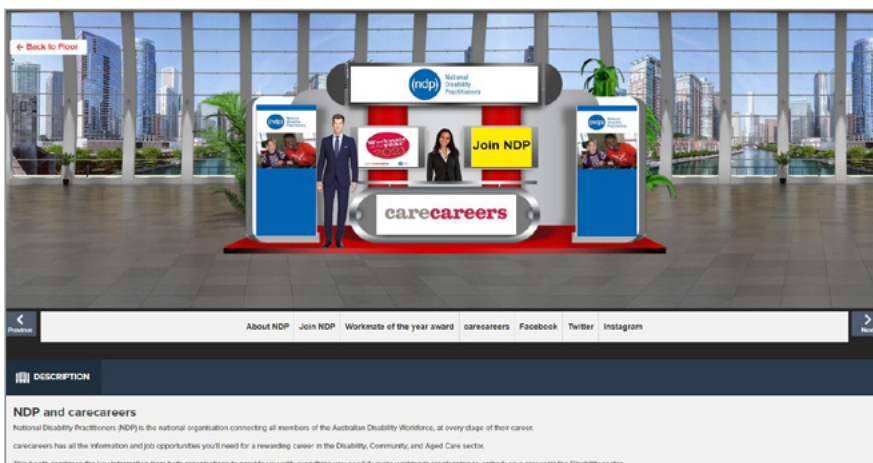
