Positive behaviour support is a respectful and ethical approach to supporting people who may use behaviours to communicate their needs. The primary goal of this evidencebased approach is to improve a person's quality of life over the long term. Positive behaviour support is about putting in place strategies to help build a person's skills and to create an environment that meets the person's needs. It follows formal assessments and interventions informed by research. By working in collaboration with families and teams to use new strategies, positive behaviour support reduces the risk to the person with disability and the people that support them.

Our conference is targeted to behaviour support practitioners who provide this support. It can be complex work and is a process that involves collaboration with families, providers and the person with disability.

This growing group of professionals varies significantly in experience and skill and is in high demand.

When done well, positive behaviour support can reduce human rights restrictions and create a better quality of life for people with disability.




