The 7th National Elder Abuse Conference will be delivered at **Wrest Point Conference Centre**, Hobart Tasmania 14-16 February 2022 and will be presented as a hybrid conference with both in person and virtual delegates.

2. REGISTRATION

2.1. Conference Attendance

All conference delegates (in person and virtual) must register via the online delegate registration portal. Registrations cannot be shared and the attendee must be the delegate named on the registration.

2.3. Payment of Fees

Payment must accompany all registrations and be made in full prior to the commencement of the conference.

The available payment options are:

- Electronic funds transfer (EFT)

Cards accepted for online payment are Mastercard, Visa and American Express. A processing fee of 3.5% applies for American Express credit cards.

Early Bird tickets must be paid in full by midnight 15 October 2021, and all unpaid Early Bird registrations will default to full price due at this time. Full Price tickets must be paid in full by midnight 11 February 2022.

2.5. Substitutions

Attendees who are unable to attend the conference are welcome to nominate a substitute delegate up until and including 31 January 2022 at no extra cost.

2.6. Cancellation policy

Welcome Function

1/2 Day Community Workshop

The ½ Day Community Workshop is a stand-alone event and is not included in a conference registration.

Workshop attendees must purchase a ½ Day Community Workshop ticket available via the delegate registration portal.

2.8. Privacy Policy

By completing this registration form, you acknowledge the details supplied by you may be made available to the conference organisers, and any suppliers working on the event (for the purpose of your involvement). A delegate listing with contact details is not published.

3. PROGRAM

3.1. Program Alterations

The conference organisers reserve the right to make alterations to the arrangements of conference/event as published, either before or during the conference/event.

The conference organisers will not take responsibility or accept requests for a refund if the guidance for viewing is not followed.

3.4. Imagery / Footage

All delegates (in-person & virtual) participating in this conference acknowledge and agree to grant the conference organisers the right to record, film, live stream, photograph, or capture you in any media now available or hereafter developed and to distribute, broadcast, use, or otherwise to disseminate, in perpetuity, such media without any further approval from you.

3.5. Conference Code of Conduct

Our event will present opportunities to learn, share knowledge and network. We believe the event should represent a safe, enjoyable and inclusive environment for all people, irrespective of gender, race, ethnicity, age, sexuality, religion, disability, socio-economic background, experience, or lived experience. No one should be subject to any harassment, bullying or abuse. Any such behaviour will not be tolerated, and the organisers will take action deemed necessary to ensure it does not recur. This may include immediate removal from the event and a prohibition from attending future events held by the conference organisers. Inappropriate conduct or behaviour can be reported to the registration desk at any time during conference hours.

3.6. COVID-19 Safe Event

The hybrid format enables limited in person participation (physical presence) as well as remote participation through an online platform. This event is being run according to the Tasmanian Government COVID Safe Event Guidelines at the time of the event.

If you are planning to attend in person you agree to the following conditions of attendance:

- comply with the COVID Safe Event Guidelines at the time of the event
- follow any requests or instructions from venue or the event organisers
- keep 1.5 metres away from other wherever possible
- avoid physical greetings such as handshaking, hugs and kisses
- practice good hygiene

Delegates are requested to not attend if they have

- fever or symptoms of respiratory infection (cough, sore throat, shortness of breath)
- return from overseas in the last 14 days
- been in close contact with a confirmed case of COVID-19 (coronavirus) in the last 14 days

4. POSTPONEMENT, CANCELLATION OR INTERRUPTION

4.1. Postponement of conference

In the event of it being found necessary, for whatever reason, that the conference/event be postponed or reschedules, the organisers shall not be liable for expenditure, damage or loss incurred by the delegate.

Existing registrations will automatically be transferred across to the rescheduled conference.

4.2. Cancellation

In the unlikely event of the conference/event being cancelled by the organisers, a full refund will be made less any credit card fees. Liability will be limited to the registration fee paid by the delegate.

4.3. COVID19 Travel Restrictions

In-person delegates unable to attend the conference/event due to COVID19 related travel restrictions, will be able to attend the conference as virtual delegates. Upon request, registrations will be transferred to an 'All Access' Virtual Delegate pass.

The 7th National Elder Abuse Conference and its organisers are not responsible for any travel costs incurred by the delegate. It is the responsibility of the delegate to arrange appropriate insurance cover in connection with their attendance at the conference/event.

4.4. Liability

In the event that a delegate is unable to attend the conference/event for any other reason (not COVID19 related travel restriction), the 7th National Elder Abuse Conference and its organisers are not responsible for any costs incurred by the delegate. It is the responsibility of the delegate to arrange appropriate insurance cover in connection with their attendance at the conference/event.

The 7th National Elder Abuse Conference and its organisers do not accept responsibility for any loss, costs, charges or fines incurred by delegates in the process of attending the conference.

4.5. Force Majeure

The conference organisers shall not be liable for any loss caused by the cancellation of all or part of the 7th National Elder Abuse Conference where such cancellation is due to Force Majeure. The organisers will use all reasonable efforts to conduct the conference despite the intervention or occurrence of any such cause.

In this clause, Force Majeure means circumstances which are beyond the reasonable control of the the conference organisers and which are reasonably likely to affect the conference organisers successful delivery of the 7th National Elder Abuse Conference or would make it inadvisable, impracticable, illegal, or impossible for a party to perform its obligations as originally contracted under this Agreement, including: fire, flood, earthquake, extreme adverse weather conditions, failure of electric power, gas, water, or other utility service, collapse of building structures, widespread disease or other public health emergency (including pandemic or epidemic), strike or other industrial action, the outbreak or declaration of war, act of terrorism, revolution or government orders or action (including the declaration of a State of Emergency).

If, as a result of Force Majeure, the conference organisers cancel the Event/s, the conference organisers shall use reasonable commercial endeavours to reschedule the Event.

Without prejudice to its obligations the conference organisers accept no liability and will not be liable for any compensation where the performance of its obligations under this Agreement is affected by Force Majeure.

5. ACCOMMODATION

5.1 Payment

Credit Card details are required as a guarantee at the time of booking. Full prepayment is required and will be charged to Individual credit cards at 48 hours prior to arrival.

A surcharge of 2.2% is applicable to AMEX payments, no surcharge will apply to VISA and MC Payments.
