Payments:

- All prices quoted are in Australian Dollars and include GST of 10%.
- Registrations are not confirmed without payment.
- Payment must be made in Australian Dollars.
- Overseas delegates must pay by credit card. Photocopies of cheques cannot be accepted as payment.

Cancellations:
