

## Reasons for Early Removal of Long Acting Contraceptive Implant in a Provincial Setting in Papua New Guinea

**Background**: Papua New Guinea (PNG) has a high maternal mortality ratio, a low contraceptive prevalence rate and a high-unmet need for family planning (FP). Although contraceptive implants have been widely used, many women have been seeking early implant removal for various reasons.

**Objective:** To investigate the reasons for early removal of contraceptive implants.

**Methods:** A prospective observational study in the FP clinic over 12 month period, looking at the reasons for early removal of Contraceptive implant.

**Results:** Of 1028 women,95% were married and majority(772) were unemployed. The mean age was 29 and the majority (71%) were between P1-3.Discouragment of FP from family members, education level and lack of proper counselling were also observed to influence implant removal.

The most common reason for early implant removal was for side effects with the most common being Irregular bleeding (211/527).

**Conclusion:** Although implant can be an effective method of meeting the high FP demand in PNG, improved level of education, increased awareness and counselling are needed in order to improve its uptake and effectiveness.
