



## **TERMS & CONDITIONS**

### **ASID EVENTS**

By registering for the Event, you agree to these terms. If you are registering on behalf of another individual, it is your responsibility to ensure the person participating is aware of these terms and accepts them.

#### **Currency and GST**

All prices are in Australian Dollars (AUD\$) and include GST, unless otherwise stated.

#### **Confirmation and Tax Invoice**

Once you have completed your registration, you will be sent a confirmation email with a Tax Invoice. Please ensure that your valid email is entered correctly on the registration form and check your junk mail folder in case your confirmation email(s) are caught by spam filters.

#### **Event Updates**

Information for attendees will be sent electronically to the email address that is provided at the time of registration.

#### **Program Changes**

The Host reserves the right to change aspects of the Event, including but not limited to, the Event name, themes, content, program, speakers, format, performers, hosts, moderators, venues, and times.

#### **Insurance**

The registration fees do not include insurance. Participants are advised to take out appropriate insurance.

We do not provide individuals against the cancellations of bookings for any reason including cancellation or postponement of the Event or for theft or damage to belongings.

#### **Registration Cancellation**

ASID will not refund registration fees for cancellations made 7 days or less before the event, unless there are exceptional circumstances. All applications for exceptional circumstances will be considered by ASID on a case-by-case basis and their decision on each case will be final (any decision to allow a refund of registration fees will incur an administrative fee of \$100.00, which will be deducted before registration fees are refunded).

**If ASID Cancels The Event due to unforeseen circumstances**

ASID reserves the right to cancel or postpone any event due to insufficient registrations or other unforeseen circumstances. If an event is cancelled or postponed, ASID will refund registration fees, less \$100 administration fee, but cannot be held responsible for other costs, charges, or expenses, including cancellation/change charges by airlines or travel agencies.

**If the Event moves from a Face to Face or Hybrid to Virtual Format**

If you have registered to attend a face-to-face Event and the Organisers are unable to hold an on-site conference due to circumstances out of their control, the Event will be held \*fully virtually and your registration will be transferred to an online registration with the difference in registration cost refunded to you.

Refunds of in person registrations will not be issued due to an event moving entirely online.

**Technical Disruption**
