

Item 5: ASBMB Treasurer's Report 2019

Treasurer Highlights AGM 2019

- Overall financial position of the Society is significantly improved compared to that of 2018. The balance sheet indicates we have total assets of \$594,064 and a total equity of \$477,176
 - Revenue up \$30,132 in 2018-2019 mainly due to increased profit share from Combio2018
 - Expenditure down \$725 in the same period
- **2018-2019 financial year** showed an operating profit of \$45,555, compared with a profit of \$14,589 in 2017-2018.
 - 2018-2019 is now the second year in a row after 7 years of losses previously (out of 8 years total).
- Items to note:
 - Increased profit from Combio2017 (25,382) vs Combio2018 (\$103,155)
 - The current ASBMB only meeting is unlikely to be a major driver of income for the society, and we are going to need the income from ComBio2018 to allow us a buffer to fine-tune the format of the biannual ASBMB only meetings.
- We need to sustain or increase membership and to ensure both the longterm viability and profitability of Combio/ASBMB meetings


