

Founded in 1946, the RANZCP has more than 7,300 members, including more than 5,300 fully qualified psychiatrists and almost 2,000 members who are training to qualify as psychiatrists.

The RANZCP has a new President elected every two years. The President first serves as President-Elect for two years prior to taking up their position.

Our vision is to improve the mental health of communities through high quality psychiatric care, education, leadership and advocacy.


### **Delegate profile**

#### Delegates attending the Congress are representative of the wider RANZCP membership and the many sub-specialty areas within psychiatry, as well as those working within the broader mental health sector.

In Australia, approximately 85% of practising psychiatrists are current RANZCP members and in New Zealand, more than 50% of practising psychiatrists are current members.

The 2021 delegates indicated a phenomenal amount of experience within the industry, with:

- 12% having 11-15 years experience
- 12% having 16-20 years experience
- 10% having 21-25 years experience
- 9% having 26-30 years experience





#### Code of Conduct: Medicines Australia

Pharmaceutical companies must adhere to the current Medicines Australia Code of Conduct in relation to display and promotion of company or product names.

All promotional design and print items will require approval by the College before the package is confirmed. The Royal Australian and New Zealand College of Psychiatrists reserves the right to approve all branding provided by supporters and exhibitors.

#### **Congress communication**

#### Registration
