
- The MMU has been on the road for over 660 days

- Unique, one-of-a-kind hospital on wheels only one in Canada








Deployments by type


Surrey Memorial Hospital (Fraser Health) November 2012

- From request to set up, the team was on-site in eight hours







Downtown Eastside Goals (initial)

- 1. Mitigate congestion at St. Paul's Hospital Emergency Room
- 2. Improve the clinical outcome of patients who sustained an opioid overdose
- 3. Provide more integrated treatment service for overdose patients
- 4. Help BCEHS transport appropriate patients to a hospital setting and get back onto the road sooner to help more patients

Downtown Eastside Complexities and challenges

"building from the ground up"

- MMU as a stand-alone unit
- Site preparation: City permits, fencing, security, washrooms, water source, electricity
- High media requests and coverage
- Unit clinically operational within 12 days of activation
- Communication between health authorities, programs, vendors: VCH, PHC, BCEHS, HEMBC, CDC, City of Vancouver, BC Hydro, Telus......






Downtown Eastside Complexities and challenges

Clinical staff & patient flow

- Inclusion & exclusion criteria
- Walk ins/Drop offs
- Staff recruitment and scheduling: Physicians, nurses, addiction specialists, outreach workers across VCH, PHC, and PHSA
- Orientation of a high rotation of clinical staff: webinar, just-in-time training
- Patient care delivery and secondary transports
- Clinical re-supply, housekeeping, parking, power, septic, oxygen, security, IMITS, leadership.....
- Mission Creep and Exit Strategy







Downtown Eastside VCH Surveillance Statistics

December 13, 2016 - Apr 6th, 2017

*(Apr 6th-May 19th)

- 163-day deployment longest in the history of the MMU program
- A total of 3,064 patients visited the MMU an average of 25 patients per day
 - 598 (20%) had overdose presentations
 - 574 (20%) presented with acuity level as emergent and urgent. For OD related visits, the proportion remained at 79%
 - 558 (19%) of visits arrived by EHS. For OD related visits, the proportion remained at 89%








Overdose Crisis Response


