#### Root Cause Analysis (RCA): Looking Past the Smoke and Mirrors To Get To The Real Causes of Workplace Incidences

Typical corrective actions from most workplace incident investigations result in re-training or re-instructing employees in safe work practices and behaviours. This requires time and money and often with very limited to zero impact in harmful risk reduction. Many are familiar with root cause analysis, including techniques such as the 5 why's and fishbone diagram; but few workplaces apply them in an effective way. This workshop, using a case study, will walk participants through a practical means of conducting and getting down to the real root cause of incidences and putting in place the proper corrective measures using the hierarchy of controls.
