Herwig Immervoll has extensive experience in policy dialogue and research on social protection, safety nets, inequality trends, minimum wages, and employment support policies. Before his role at the OECD, he worked at the World Bank and the University of Cambridge, where he was involved in developing EUROMOD, the EU-wide tax-benefit model. He is also a Research Fellow at the Institute of Labor Economics (IZA) in

Bonn and a Research Associate at the Institute for Social and Economic Research (ISER) at the University of Essex. His research has been published in OECD and World Bank reports, as well as in academic journals including the Economic Journal. Journal of Public Economics, Journal of Economic Inequality, Review of Income and Wealth, and International Tax and Public Finance. He specializes in microsimulation methods and their application to policy analysis and evaluation. Currently, his work focuses on adapting social protection to the changing nature of work, developing tools for people-centered employment-support policies, exploring the implications of a Universal Basic Income, and assessing the impact of economic crises on employment and social policies. Herwig holds a PhD in economics and Masters degrees in economics (development and public finance) and business administration (IT and personnel management). He became a Research Fellow at IZA in December 2004.
