He has spearheaded Pakistan's first digital socio-economic census covering over 35 million households of the country and established the NSER. He has designed and implemented successful health and nutrition and education focused CCTs across Pakistan. Naveed has also designed and implemented several targeted subsidies and shock-response initiatives for poor and ultra-poor segments of the country, including noteworthy emergency cash assistance during COVID 19 and response to recent monsoon floods in Pakistan. Mr. Naveed holds a M.Sc Economics & Finance with a distinction.

Namrata Singh has been working as Province Secretary, Ministry of Land management, Agriculture and Cooperative, Madhesh Pradesh Nepal for the last two years.
