Shahra Razavi, Director, Social Protection Department, International Labour Organization (ILO)

Shahra Razavi is a distinguished development economist with more than 25 years of experience in social policy, social protection, gender, and development. As the Director of the Social Protection Department at the International Labor Organization (ILO), she plays a crucial role in shaping global initiatives. Her previous positions at UN Women and the United Nations Research Institute for Social Development (UNRISD) have allowed her to make significant contributions to understanding gender dimensions in economic policy, poverty,

livelihoods, land rights, and social policies. With an extensive body of published work, Shahra Razavi is recognized as a leading expert in her field. Her ongoing efforts continue to drive positive change and promote greater equity and inclusivity in societies worldwide.



Michael Samson, Research Director, Economic Policy Research Institute (EPRI)

Michael Samson is the Research Director of the Economic Policy Research Institute (EPRI), a global research institute with offices in Bangkok, Cape Town, and San Juan. He has 36 years of experience working in social protection, and specialises in designing, implementing, monitoring and evaluating integrated social protection programmes, policies, and systems; and his project experience in these areas includes work in 58 countries in Africa, Latin America, Eastern Europe, Asia and the Pacific as well as many related publications. He has conducted integrated social protection and public finance reviews in Cambodia, Indonesia and the Kyrgyz Republic. He led the international team supporting the evaluation of Thailand's Child Support Grant, designed a long-term social protection training-of-trainer capacity development programme in Vietnam, and supported 32 other social protection policy and programme-related projects over the past fifteen years in Asia and the Pacific. His current work explores the role of social protection as the vital social dimension of integrated climate, development and equity strategies. He is also on the economics faculty at the Williams College Center for Development Economics in the United States, and he has a Ph.D. in Economics from Stanford University.

Arup Kumar Chatterjee is a Principal Financial Sector Specialist at the Asian Development Bank, working on reforming and developing capital markets, contractual savings, and insurance sectors. Her latest publication - a co-edited book - is entitled Informal Workers and Social Contracts in the Global South (Elgar), which aims to interrogate the idea of social contracts from the grounded perspective of workers in the informal economy.
