With over two decades of experience in various positions of responsibility, Hasan has a proven track record in policy analysis, formulation, and evaluation.

Hasan has made significant contributions to the field of social protection policy and has authored several publications, including "Social Capital of Community Organizations for Enhancing Social Protection: Experiences of Japan and Bangladesh," published in the Journal of Social Development in Dhaka. He has also contributed to numerous government reports and seminar papers, such as "Development Centric Model of Social Protection in Bangladesh: An Analytical Overview". Currently, Hasan serves as Joint Secretary (Civil Registration and Social Security) in the Cabinet Division of the Government of Bangladesh, where he leads efforts to improve the efficiency and effectiveness of the social protection system. Prior to his current position, he worked as a Social Protection Specialist for the Social Protection Policy Support (SPPS) Programme at UNDP Bangladesh from 2015 to 2020.



Bernadette Balamban Chief Statistical Specialist Philippine Statistics Authority

She is the Chief Statistical Specialist of the Poverty and Human Development Statistics Division and one of the Team Leaders of the SDG Team of the Philippine Statistics Authority (PSA), which is responsible for the overall coordination and monitoring of the SDG indicators in the country. Their unit is also responsible for the estimation of the official poverty statistics of the Philippines and coordinator of the Technical Committee on Poverty Statistics.

She has been with the Philippine government since 1999 through the former National Statistical Coordination Board, which is now part of the PSA.
