

Dr. Katinka Weinberger has 25 years of experience in sustainable development, agriculture, and the environment at international level, working through multistakeholder processes, and focusing on the interconnections of economic, social and environmental dimensions of development. Currently, as Chief of the Sustainable

Socioeconomic Transformations Section, she leads ESCAP's engagement in Inequality, Social Protection, and Leave No One Behind.

Previously, as Chief of the Environment and Development Policy Section, she led the establishment of the Asia Pacific Forum on Sustainable Development as an annual, inclusive intergovernmental forum, and was responsible for key issues related to the environment and the 2030 Agenda for sustainable development, including on climate ambition, food systems, ecosystems health and environmental governance. Before joining EDPS she was the Head of the Centre for Alleviation of Poverty for Sustainable Agriculture and previously worked in different scientist positions within the Consultative Group of International Agricultural Research (CGIAR).

Ms Weinberger holds an Engineering Degree in Agricultural Economics, and a PhD in Development Economics, both from the University of Kiel, Germany.

Humphrey Fellowship, specialized in Public Health Policy and Management from Emory University, during which he served at the US Center for Disease Control and Prevention. He worked for the Carter Center Mental Health Program and the Permanent Mission of Maldives to the United Nations, Committee on Social, Humanitarian and Cultural Issues.
