These terms and conditions constitute a contract between you ('the Exhibitor/Sponsor'), the **Australian Society for Music Edu**cation (ABN: 53 106 346 200) and **All Occasions Group Pty Ltd** (ABN 44 109 863 514) ('the Conference Organisers') in relation to the sponsorship and/or use of virtual exhibition space for the **ASME XXIII National Conference 2021** through the **Virtual Platform** ('the Venue') from Conference Dates ('the Conference'). By signing the application form you are indicating your acceptance of these terms and conditions.

#### Acceptance and Allocation
