



WIPCE 2020 – Accommodation Terms & Conditions

Intercontinental Adelaide

Terms and Conditions – One night deposit payable upon confirmation of room. Cancellations made within 30-7 days prior to the check in date incur first night's accommodation as cancellation fee. Cancellations made within 7 days prior to the check in date, or early departures or no-shows will incur a cancellation fee equivalent to the room rate for each night that is cancelled or reduced. Rooms must be paid in full 7 days prior to arrival. Credit card merchant fees of 1.5% for Visa and Mastercard and 3% for American Express, Diners Club and JCB

Mercure Grosvenor

Terms and Conditions – Accommodation bookings cancelled prior to 30 days of arrival no cancellation penalties will apply. 30 -7 days prior to arrival cancellation fee equal to 1 night will apply. Within 7 days of arrival 100% cancellation fee will apply.

Stamford Plaza Adelaide

Terms and Conditions – Any cancellations within 30-14 days of arrival will attract a 1 night cancellation fee. Any cancellations within 14 days of arrival will attract full cancellation fees. Guest credit cards will be required on check in where the remainder of the accommodation and \$100 pre authorisation will be held and charged at check out.

Holiday Inn

Terms and Conditions – One night deposit payable upon confirmation of room. Cancellations made within 30-7 days prior to the check in date incur first night's accommodation as cancellation fee. Cancellations made within 7 days prior to the check in date, or early departures or no-shows will incur a cancellation fee equivalent to the room rate for each night that is cancelled or reduced. Rooms must be paid in full 7 days prior to arrival. Credit card merchant fees of 1.5% for Visa and Mastercard and 3% for American Express, Diners Club and JCB

The Playford Hotel

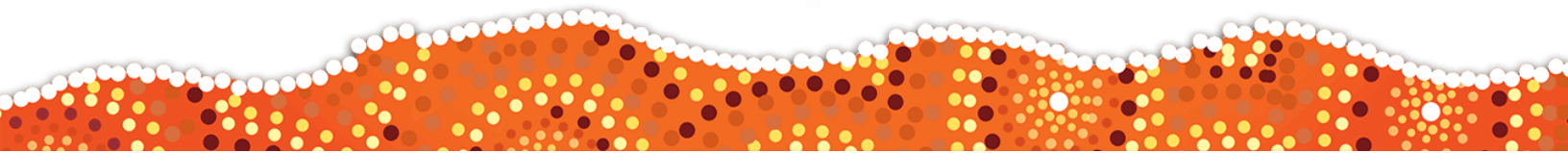
Terms and Conditions – Bond: Upon check in all guests will be required to present a credit card for pre-authorisation to cover incidental charges. Rooms may be cancelled up to 30 days prior to arrival without penalty. 30-7 days prior to arrival a cancellation charge equal to 50% of the total accommodation will apply. From 7 days prior to arrival any room nights cancelled will incur a charge equivalent to the full duration of the booking. Non arrivals will incur a fee equal to 100% of the accommodation not utilized.

Stamford Grand

Terms and Conditions – Outside of 31 days, rooms may be cancelled or reduced without charge. Cancellations between 30-14 days of arrival will incur a 1 night cancellation fee. Any cancellations 14 days prior to arrival will attract full cancellation fees. All non-arrivals will be charged for a one night no-show charge.

Miller Apartments

Terms and Conditions – Less than 30 days' notice for cancellations will incur a penalty equal to the first night's accommodation. Less than 7 days' notice or 'No Shows' will incur a penalty equal to 100% of the total accommodation cancelled.

Oaks Embassy, Oaks Horizon and Oaks iStay Precinct

Terms and Conditions – Bond: Oaks require a credit card imprint for incidental charges at check in.

Bookings cancelled up to 30 days prior to arrival – no penalty applies. Bookings cancelled between 30-14 days prior to arrival – cancellation fee equal to 1 night for every confirmed booking cancelled will apply. Bookings cancelled within 14 days of arrival – all rooms cancelled or no shows will be charged the full stay

Quest on Franklin

Terms and Conditions – The first nights' accommodation is payable when the room is confirmed or 30 days prior to arrival, by accepting the terms and conditions you authorize AOG to safely provide your credit card to the hotel for processing.
