

#### **Acceptance and Allocation**

#### **Cancellation Policy**

Cancellations will be accepted in writing only. A cancellation notice received prior to 3 months from the Seminar start date will be subject to a 50% cancellation fee. A cancellation notice received within 3 months of the Seminar start date will be subject to a 100% cancellation fee.

#### Legal Responsibility
