### CANCELLATIONS

All cancellations must be advised in writing.

Once the booking has been confirmed within 30 days prior to departure date of 2 November 2024, all cancellations will incur a fee of 100% of the total booking value in addition to the \$250 non-refundable cash deposit paid at your PlaceMakers store.

Cancellations outside of 30 days prior to departure will incur fees as outlined below in addition to the \$250 non-refundable cash deposit paid at your PlaceMakers store.
