
## Initial Activation of the RSS Warehouse

- Meets requirements of the Assistant Secretary of Preparedness and Response (ASPR) SNS Program
- Strong security component




- March 19, 2020: 25% pro rata allocation based on population
- March 29, 2020: 25% pro rata allocation based on population
- April 10, 2020: Remaining 50%
- March 12, 2020: Dear Recipient Letter from ASPR

## Allocation of Scarce Resources

#### Scarce PPE Allocation Decision Tree

Does the facility or agency meet **all** of the following criteria:

- Depleted supply or will be depleted in one week
- Impacted ability to ensure patient care and/or worker safety due to shortage or depletion
- Exhausted attempts to secure PPE from other sources
- Consistently implemented CDC strategies to optimize use of N95 respirators








# RSS Phase II: April 20–June 12, 2020






## RSS Phase III: June 13–August 28, 2020



# RSS Phase IV: August 28, 2020–February 2021











# WEM, SEOC-EM, Tribal Health Centers Weekly Surveys


- March 2020–June 2021






# Ventilator Stewardship Program

1500 ventilators purchased by State of Wisconsin

- Owned by state but available to loan
- Maintained in partnership with KKM
- Stored by Private Warehouse
- 304 deployed to 55 entities since September 2020
