Please ensure your hotel reservation is made by **15 June 2023**. After this date, room availability is not guaranteed.

Individual Bookings

Bookings up to 3 or less rooms have to be made via the <u>on-line booking form</u>.

Group Bookings

Bookings for 4 or more rooms are subject to different terms and conditions. Reservations will be allocated on a "First-come, First-serve" basis.

Payment Terms

- 1) Pre-payment of the total stay is requested upon confirmation.
- 2) Booked hotel rooms are binding and must be paid in advance.
- 3) Payments can be made by credit card (Visa, Mastercard, Amex). There will be a handling fee for credit card payments of 2,5% (Visa, Mastercard, 4,5% Amex).
- 4) All extras have to be settled directly at the hotel.
- 5) All refunds will be processed after NetSci2023.

Cancellation and Alteration Terms
