



## Consent for Post-Course/Congress Use of Presentation Recordings

Thank you for participating as a presenter in the WMS Pre-Congress Teaching Course/ Congress/ organised and held by WMS Congress Limited.

**In this Consent Agreement, the following words shall have the following meanings:**

**Intellectual Property Rights:** shall mean any copyright, rights in performance and neighbouring and related rights, moral rights, goodwill and the right to sue for passing off, design rights, rights in computer software, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world.

**Organiser:** shall mean the WMS Congress Limited, with company number 10385332 and having its registered office at The Old Cider Press, 5 The Quay, Tuckenhay, Devon, United Kingdom, TQ9 7EQ;

**Party (or Parties):** shall mean the Organiser and you, and 'Party' will mean either one of them;

**Recordings:** shall mean the video and audio recordings in part or full, of the presentation given by you during the WMS 2024 Congress and/or WMS 2024 Pre-Congress Teaching Course, including any PowerPoint slides or written documents shared, and any transcripts produced of the same;

**WMS 2024 Congress:** shall mean the 29th Annual Congress on behalf of the World Muscle Society, held in person and virtually between 8<sup>th</sup> and 12<sup>th</sup> October 2024 at the Prague Congress Centre, Prague, Czechia and via Events Air virtual platform and organised by the Organiser.

**World Muscle Society:** shall mean the World Muscle Society, with registered charity number 1126862 and having its registered office at The Old Cider Press, 5 The Quay, Tuckenhay, Devon, United Kingdom, TQ9 7EQ.

**The following consent statement pertains to presenters at the upcoming WMS 2024 Congress and WMS 2024 Pre-Congress Teaching Course, who, by taking part as a presenter, acknowledges and confirms agreement to the terms set out below relating to the recording of their presentation/s:**

## Consent Agreement

1. The presenter agrees not to withhold any slides from the presentation for post-congress use.
2. The presenter represents and warrants that their presentation is original and that the Organiser has the right to perform and present said presentation on video format and the rights to permit its use, reproduction, transmission and display on behalf of you, pursuant to the terms of this Agreement. The Parties will have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this agreement, and that the Parties shall have no claim for innocent or negligent misrepresentation or negligent misstatement based on any statement in this agreement.
12. No variation of this agreement shall be effective unless it is in writing and signed by the Parties (or their authorised representatives).
