A Strategy Safari: Exploring the Scenario Thinking Platform for the European Commission's next Framework Programme for Research and Innovation (FP10)

Science, technology, research and innovation are a prerequisite for achieving a global sustainable economy. Global research and innovation are a means for ensuring that any transition leads to global wellbeing. The EU's Research and Innovation (R&I) Funding Programme Horizon Europe, as one of the largest such programmes in the world, is a steppingstone into tackling the sustainability challenges globally and the strategic planning of the next Framework Programme (FP10) is about to start. If it is to tackle both known and, as yet, unknown global challenges, what should it look like and what relevance and importance might this have for other national or international R&I funding programmes?

In this workshop, we will use four possible scenarios of the world in 2028 defined by representatives of the <u>League of European Research Universities</u> in their preparation for the strategic planning of the European Commission (EC). Scenario thinking is meant to motivate people to challenge the status quo. This allows us to rehearse the possibilities of tomorrow, and act today empowered by those provocations and insights. Because scenarios are hypotheses (not predictions) they are used in sets of four stories that capture a range of future possibilities: good, bad, expected, surprising. Thus, scenarios can be utilized to inform strategy.

Four international delegates are invited as "Agents of Change" to develop and discuss with the participants four different potential structures of FP10. Each "Change Agent" will represent a different global region offering their specific lens on the upcoming programme. They will be supported by four facilitators, experienced in scenario thinking. Such scenario thinking will also be useful for other national or international funders interested in addressing future challenges.

Jennifer Ponting is Associate Vice President for Research Administration and Director, University Research Administration. Prior to joining UChicago, she was the Director, Pre-Award Services in the Office for Sponsored Programs at Harvard University. Jennifer also served as a Senior Contract Officer at Columbia Technology Ventures, the tech transfer and licensing office at Columbia University, as well as the Export Control Officer and Contract Specialist for the Massachusetts Institute of Technology.
