

## **Experiences and reflections when incorporating the Nutrition Care Process and Terminology – (NCP/NCPT) into electronic health records**

### **Dr Angela Vivanti, Princess Alexandra Hospital (Australia)**

Dr Angela Vivanti is an Advanced Accredited Practicing Dietitian and the Research and Development Dietitian at the Princess Alexandra Hospital, Brisbane, Australia. She is Australia's representative and chairs the Nutrition Care Process Terminology Research Outcomes Committee and has previously chaired the Nutrition Care Process Terminology International Workgroup.

This work progresses the professional implementation of a standardized Nutrition Care Process Terminology including integration into SNOMED-CT International to optimize the interface with electronic health records for the transformational (and not just transitional) opportunity that it offers. Angela has been on the scientific committees of international and national conferences over many years. She has co-authored a text book, peer reviewed articles, abstracts, evidence-based guidelines and systematic reviews including Cochrane reviews.
