Monash University is one of Australia's leading organisations for education and research. It processes around 1,600 new human ethics applications, along with 400 animal and 150 Gene tech applications a year.

Before using Ethics RM, applications were paper-based

A combination of Excel, Research Master and HP Records Manager was used to capture data and file applications. Hard copy applications were posted to reviewers, which wasted time and increase the potential for missed deadlines and errors.
