

• Research and Operational Partnership: We can only move forward together

Research administration cannot occur in a vacuum, like the spoke of a wheel, the research administrator is the agent who should connect and have a degree of understanding of all other operational units involved in conducting research: contracts, procurement, finance, HR, health and safety. For a new or growing research office it is vital to employee experts in research who have the knowledge and understanding of this various fields and can navigate among them to cooperate and create cohesive change. The purpose of this panel is to provide a forum for viewing research development from these varying operational perspectives and identify where the challenges lay. The open dialogue is an opportunity for these representatives to provide their point of view and view of challenges in the hopes of identifying the common ground – and creating productive ways to create solutions as a team. Similar to a mock-debate, a series of common faculty complaints will be read aloud to the group – the relevant offices will then be provided the opportunity to both justify and refute the complaint. The floor will then be open to shared dialogue to pose means and methods for preventing or reducing the complaint in the future. As experts in their field, this will give attendees the chance to hear how various institutions address these problems and create creative ways to find effective solutions.
