

### ● Research Management – A Profession to Count on!

Research management and administration (RMA) has become an integral (though sometimes undervalued) element of the research environment. It requires professional staff to not only provide research support-related services to researchers but also to support the development and enhancement of the institutional research portfolio, and that of individual researchers working within the institution.

Globally, we are transitioning to a new way of working. We need to adapt and anticipate current funder and research management trends and how this impact on the skills required within the “new normal”, also including post-pandemic and digital transformation. Without agile RMA expertise it would be impossible for the researchers to succeed.

This session will provide:

- 1) A review of some of the typical functions of research support structures (focusing on: grants management, policies and compliance, research information management) and the core responsibilities, competencies and skills required to effectively address these functions in the research support office.
- 2) group discussions around own RMA experiences, and tips on how to acquire skills
- 3) A focus on the role of professional networks in influencing the growth of research management profession and the professionalisation of RMA: How do these networks help us in becoming better professionals, what opportunities do they bring? This includes discussion sessions of some of the training and capacity building opportunities available globally. Representatives from the various networks will illustrate programmes or certifications available for training, professional development.

Opportunities for mutual learning will be provided with a focus on early- and mid-career Research Managers and Administrators (RMA's).

Participants to this session should be ready to engage actively in discussions.
