INORMS 2023

COLLABORATIVE **LEARNING SESSION**



Exploring project, institution and national risks of international research collaboration.

This session will introduce the topic of risk in international research collaboration, covering areas such as risk appetite, the role of RMAs in decisions or recommendations on risk levels and balancing the different drivers of our Institution so that we can manage risk accordingly and continue to facilitate the fantastic international research collaborations that we all want to be part of.

Through two separate blocks of group work the delegates will first be asked to list all the different types of risk that they consider when working with international partners at three different levels. Firstly at a project level so this could include potential risks in delivery of project objectives, for example if an extreme weather event jeopardises field work. Then at an institutional level, for example potential reputational risks to your organisation and finally and a national level for example if geo-political issues such as sanctions arise. Delegates will be asked to feedback from their groups, creating a shared list of possible risks to consider.

The second block of group work will see the delegates being given a scenario to discuss, to consider what risks might arise from it and any mitigations they might consider putting in place. They will also be asked to create a newspaper 'headline' that demonstrates how reputational damage can occur. Delegates will be encouraged to be creative and fun with their 'headline' as this is the last session before congress close. Feedback to the room will finish this last set of group work, and the workshop will close with a few comments and suggestions and an opportunity for questions from the delegates.
