## Towards a utopia for Indigenising Research Management and Administration

Research Management and Administration (RMA) within African Higher Education Institutions (HEIs) are experiencing unique challenges throughout the research ecosystem. Addressing these challenges necessitates university leadership and Research Management Professionals (RMPs) with strategic and critical thinking skills. Partnership and collaboration are furthermore crucial to bring about positive change in the RMA environment. In this regard, the RMA environment includes the tools, policies and procedures, and codes and standards that relate to governing RMA. RMA practice is influenced by Euro-Western viewpoints, with too little attention paid to deliberate methods of fostering equality, diversity, inclusion, and indigenisation in leadership, research, and professional development. Consequently, we argue that RMPs can be catalysts for intentional reform by promoting the Indigenisation of RMA in African universities.

In advocating for indigenisation, and addressing RMA-related challenges, RMPs need a framework to guide and support them in applying the critical competencies needed to negotiate the changing environment. The (r)REAL framework that we are proposing is a whole-system change strategy aiming to guide RMPs in advocating for indigenisation in the RMA environment. This framework applies to all RMPs regardless of the level of appointment. Through this framework, we strongly advocate for the indigenisation or RMA and the co-creation of an African RMA / RMP identity that reflects an inclusive community.
