The Intellectual Property Rights from Publicly Financed Research and Development Act 51 of 2008 has placed various obligations on public institutions in South Africa. These obligations pertain to the management and commercialisation of intellectual property – meaning that public institutions may now not only be the originators of intellectual property resulting from publicly financed R&D but also be its custodians.

The Act identifies various duties that oblige public institutions to put in place practical measures, procedures and mechanisms to:

- identify, protect, develop, manage and commercialise intellectual property (IP);
- assess IP to determine whether it merits statutory protection – and if so, apply for such protection;
- protect know-how appropriately before it is published or publicly disclosed; and
- disclose IP to a National IP Management Office (NIPMO).

To perform these duties, the Act requires institutions to set up technology transfer offices, staffed by appropriately qualified personnel who have the knowledge and expertise required

to identify, protect, manage and commercialise IP. The obligations arising from the IPR-PFRD Act pose a challenge to newly established technology transfer offices, especially as the IP environment is complex. Specialised knowledge, skills and extensive experience are required – which Spoor & Fisher can offer.
