INTRODUCTION

ADSA and NSSA look forward to hosting the 2023 Nutrition Congress in-person, at the **Lord Charles Hotel, Somerset-West, Western Cape, 18-20 April 2023**. It will be one of the first large nutrition-related congresses held in person since 2019 in South Africa.

The Nutrition Congress is traditionally held every 2 years, and hosted by ADSA (Association for Dietetics in South Africa) and NSSA (The Nutrition Society of South Africa). We expect approximately 400 delegates to attend, and plan to host a robust scientific programme addressing various interests and focus areas in the field of Nutrition and Dietetics. SPONSORSHIP & EXHIBITION OPPORTUNITIES

The organising committee appreciates the support of private sector participants, in the form of sponsors or exhibitors.

It is the mandate of the committee to ensure that all participating sponsors and exhibitors are aligned to the principles of the hosts, ADSA and NSSA. In line with this mandate, the committee is actively seeking sponsors and exhibitors which do not offer a conflict of interest to our cause.

As such, the decision has been taken not to allow companies manufacturing breastmilk substitutes and other designated products as defined in R991 (Regulations relating to Foodstuffs for Infants and Young Children) to participate as sponsors or exhibitors in the 2023 Nutrition Congress, however, please see the Information Hub option below. Similarly, among food and beverage companies, we aim to avoid those that promote unhealthy food and products to the population in general.

All interested organisations are required to complete an online application form to determine suitability to participate in the Congress. The organising committee reserves the right to include companies/organisations as sponsors or exhibitors. INFORMATION HUB

ADSA and NSSA take cognisance of the fact that sharing information with its members is important, and in the interest of members wanting access to product information, an online hub where product information can be shared, will be set up.

Participation will be free of charge.

Participation will be limited to confirmed exhibitors at the 2023 Nutrition Congress and companies not exhibiting due to the sponsor guidelines regarding designated products in terms of the R991.
