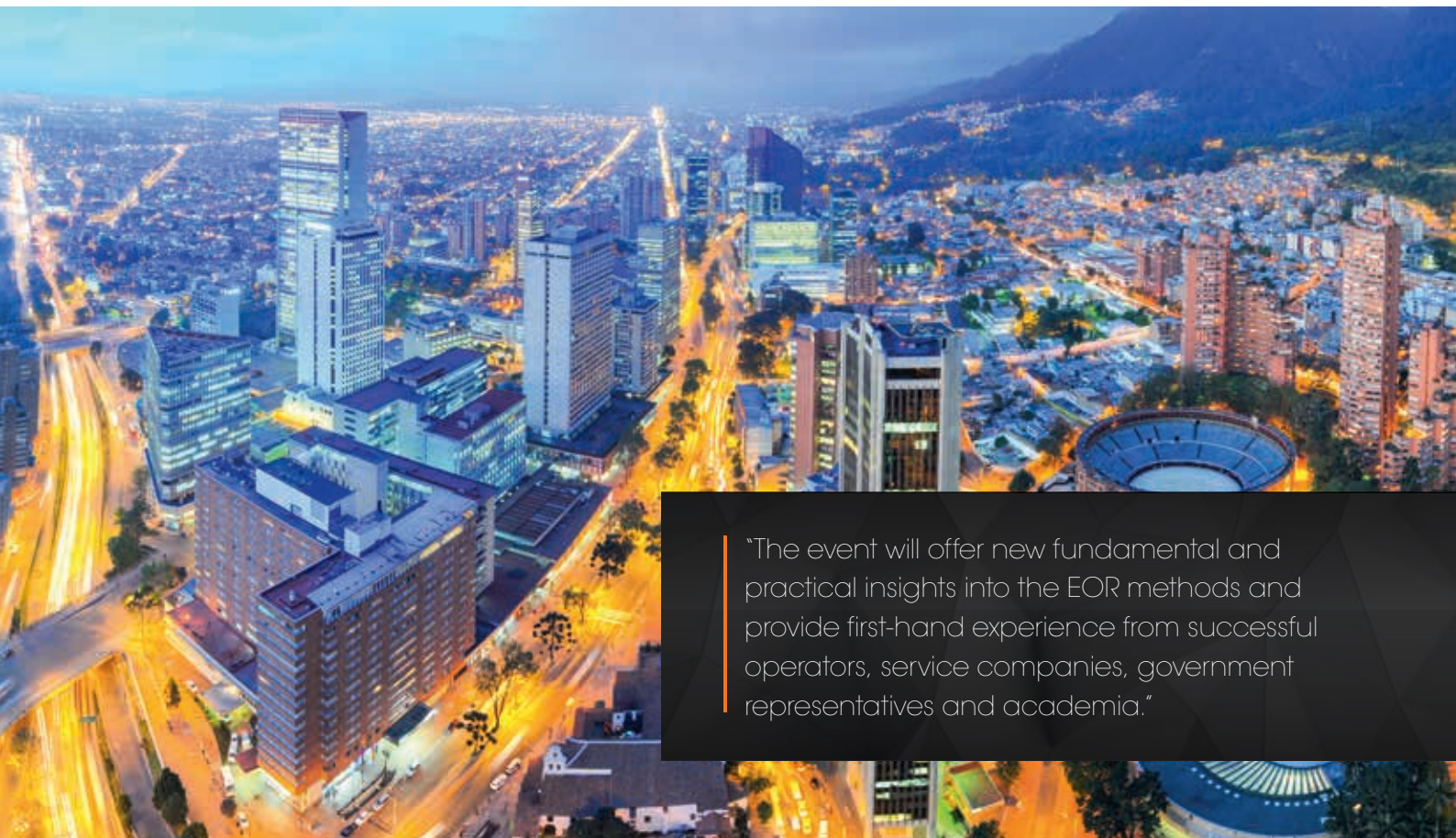
TOPICS
