Business Travel Policy for Foreign Nationals

- 1. Apply for a **Special Entry Permit** with an R.O.C. overseas mission by submitting relevant documents and forms.
 - ➤ Please note that only business travelers are permitted to enter Chinese Taipei, with the duration of stay limited to 3 months.
- 2. A qualified quarantine hotel has to be booked in advance.
 - List of quarantine hotels in Taipei: https://taiwan.taiwanstay.net.tw/covhotel/
- Upon entering Chinese Taipei, all foreign nationals must present an Englishlanguage certificate of a negative COVID-19 test taken within 3 working days of boarding the flight to Kaohsiung.
- 4. From 48 hours before you're due to arrives in Kaohsiung, foreign nationals must log into the "Quarantine System for Entry" using their cellphones.

- 5. Travelers must take designated private transfer from the airport to the booked quarantine hotel and undergo a 14-day home quarantine period.
 - Please note that the transfer is self-paid and will have to bring you non-stop to you quarantine hotel, regardless of its location in Chinese Taipei.

Summary of business travel (Updated: 7 Oct, 2020)

Pre-travel

Application to the Central Epidemic Command Center (CECC) of the travel reason (strictly for business travel – duration stay for less than 3 months)

- Low risk (e.g. New Zealand, Macao, Palau, Fiji, Brunei, Thailand, Mongolia, Bhutan, Laos, Cambodia, Nauru, East Timor, Mauritius, Vietnam, the Marshall Islands)
- Medium risk (e.g. Singapore, Hong Kong, Australia, Sri Lanka.)

Submission of Health certificate (with COVID19 test result)

Arrival

- Private transfer to quarantine hotel
- Quarantine 5 to 7 days
- COVID19 test (self-paid)
- Free movement with control in 14-day period (enhanced self-health management)

Departure

COVID19 test (self-paid) 3 days before departure (if staying less than 14 days)
