

This research aimed to review the CIRIT model using facilitator dialogical reflections.


Objectives of the research were to



Key Findings - Effectiveness of Delivery





Strengths

"...having breakout rooms, the idea of having peer-to-peer learning, you know that active learning methodologies for me I think there [is] a real strength" Transcript 1, Facilitator 2



Key Findings - Future Development







Opportunities

"...we could have a whole suite of different seminars that... complemented each other" Transcript 2, Facilitator 2

"...we need to solidify and find our focus for us as a group, but perhaps down the line, we can look at expanding that out and inviting in other, institutions into the group to essentially get that national ... approach"

"...national developments in terms of projects... Even for us to feed into and not necessarily participate, but to utilise our knowledge and experience as a group" Transcript 2, Facilitator 3

"...provide training for institutions" Transcript 2, Facilitator 3

"...exploring having bite-sized CIRIT workshops"

"...as a force in research and science in Ireland"

"I think having a website or some sort of online base would be really helpful" Transcripts 3, Facilitator 2

"Open Science Framework...I think that there's an opportunity to grow there" Transcript 2, Facilitator 4

"...that people can get micro-credentials they need to mean something ...we could turn that into a digital badge or a micro-credential on a national level" Transcript 3, Facilitator 3

"...extending our audience outside of Ireland" Transcript 2, Facilitator 2





Conclusions & Recommendations

"...this is only the start of the conversation" Transcript 3, Participant 2

"...threats are very real...I think if we had come to a point where we had very few opportunities...we'd be...at a stumbling block. I think there's a real positive that we have a purpose. There [are] lots of things that we can do and that we can support people in the area of research integrity"
