COURSE DESCRIPTIONS

FI-210	G-131
Wildland Fire Origin & Cause Determination	Wildland Training (FFT1) for Structural Firefighters
The primary purpose of this course is to provide a consistent knowledge and skill base for the Wildland Fire Investigator (INVF). The concepts taught in this course will help an INVF perform at an acceptable level on a national basis without regard to geographic boundaries.	Course is designed to provide wildland firefighting skills (Firefighter Type 1) to structural firefighters who meet NFPA 1001 for Structural Firefighter 2 or equivalency. Course objectives include: Accurately use navigation tools and maps to identify location. Describe the sizeup elements in a fire situation. Identify position responsibilities and demonstrate the ability to apply principles of Operational Leadership found in the Incident Response Pocket Guide (IRPG), PMS 461. Demonstrate the ability to apply tactical decision-making procedures.
Prerequisite(s): Completion of pre-selection assessment and pre-work <i>*Specialty Rate - \$450</i>	Prerequisite(s): Structural firefighters who meet NFPA 1001 for Structural Firefighter Type 2 & are qualified as wildland Firefighter Type 2
L-280	S-130/190 – 5 Day
Followership to Leadership	Firefighting Training/Intro to Wildland Fire Behavior
Course is designed as a self-assessment opportunity for individuals preparing to step into a leadership role. The course combines one day of classroom instruction followed by a second day in the field with students working through a series of problem-solving events in small teams (Field Leadership Assessment Course). Topics include leadership values and principles, transition challenges for new leaders, situational leadership, team cohesion factors, ethical decision-making, and after-action review techniques. Some course delivery may be arduous in nature.	Introductory course designed to train entry-level firefighters, Firefighter Type 2 (FFT2). Course covers basic incident management organization, firefighting techniques, suppression equipment, safety, strategy/tactics along with fire behavior. Field exercises will be performed for valuable hands-on training. Includes L-180.
Prerequisite(s): Experience on incident assignments in operations or support functions. Successful completion of L-180, Human Factors in the Wildland Fire Service. Satisfactory completion of pre-course work. Course is also suitable for any employee who is entering a leadership role	<i>*No Charge to Nassau/Suffolk Volunteer Firefighters</i>
Prerequisite(s): Experience on incident assignments in operations or support functions. Successful completion of L-180, Human Factors in the Wildland Fire Service. Satisfactory completion of pre-course work. Course is also suitable for any employee who is entering a leadership role	Prerequisite(s): None
S-130/190 Field Days Only	S-131
Firefighting Training/Intro to Wildland Fire Behavior (Field Days Only)	Firefighter Type 1
This course is for individuals who have taken S-130/190 online. Students must submit proof upon arrival to the academy that they have completed the online portion of this class. Please visit the Wildland Fire Learning Portal at wildlandfirelearningportal.net/ to complete the online requirements for S-130, S-190, and L-180 (On Demand Self-Enroll Courses).	This course is designed to meet the needs of an Advanced Firefighter Type 1 (FFT1). Course is interactive and contains several tactical decision games designed to facilitate learning. Topics include: fireline reference materials, communications and tactical decision making.

Prerequisite(s): S-130/190, L-180 Online course <i>*Specialty Rate - \$160</i>	Prerequisite(s): Qualified as FFT2
S-211	S-215
Portable Pumps and Water Use	Fire Operations in the Wildland/ Urban Interface
This course gives students practical knowledge and application skills in portable pump operations. Field exercises will train students in the setup and operation of a portable pump along with foam applications. Presentation to include pros and cons of retardant use.	This course is designed to assist initial attack incident commanders and company officers in confronting wildland fires that threaten life, property, and improvements. Course is also suitable for volunteer firefighters who have leadership roles in fire companies that respond to wildland fires.
Prerequisite(s): None	<i>*No Charge to Nassau/Suffolk Volunteer Firefighters</i>
	Prerequisite(s): FFT1 qualified. Must be knowledgeable of agency's firefighting policy relating to wildland/urban interface fires

COURSE DESCRIPTIONS

S-219	S-230
Firing Operations	Crew Boss (Single Resource)
Identify the roles/responsibilities of the Firing Boss (FIRB) for planning, execution, safety, coordination, and evaluation of ignition operations on a wildland or prescribed fire. Describe/demonstrate the applications of various firing devices. Students will prepare a firing plan and briefing that discusses fire behavior, firing techniques, resource requirements, coordination, safety, and risk factors to meet specific objectives.	Course provides students with the knowledge and skills to perform the duties of the Crew Boss (CRWB) position (NWCG Incident Position Standards for Crew Boss, PMS-350-98). Topics include travel and check-in in, briefings, assigning tasks and assessing crew performance, implementing fire line duties, mop-up, firing operations, using aerial resources, medical emergencies, and wildland urban interface.
Prerequisite(s): Qualified as a FFT2 <i>*Specialty Rate - \$270</i>	Prerequisite(s): (FFT1) and successful completion of Intermediate Wildland Fire Behavior (S-290)
S-231	S-290
Engine Boss (Single Resource)	Intermediate Wildland Fire Behavior NEW 2-Day Blended Course
Course designed to produce student proficiency in the performance of the duties associated with Engine Boss, Single Resource (ENGB). Topics include engine and crew capabilities and limitations, information sources, fire sizeup considerations, tactics, and wildland/urban interface. Course objective is to enable the student to perform the tasks of an Engine Boss in making the tactical decisions required to safely manage an engine on an incident.	New 2-Day blended S-290 course which includes approximately 16 hours of online course work and 2 days in-person to review and complete exercises! Course objectives include: characteristics of fuels, weather, & topography that influence wildland fire behavior; interaction of fuels, weather, and topography on wildland fire behavior, fireline tactics, and safety; causes of extreme fire behavior conditions (long range spotting, crowning, and fire whirls) that develop due to weather, fuels, and/or topography. Interpret, communicate, apply, & document wildland fire behavior and weather information.
Prerequisite(s): FFT1 and successful completion of S-230 Crew Boss (Single Resource)	Prerequisite(s): Completion of S-190 Introduction to Wildland Fire Behavior. Satisfactory completion of online course work through the Wildland Fire Learning Portal (approximately 16 hours).
S-300	S-390
Extended Attack Incident Commander	Introduction to Wildfire Behavior Calculations
Course is designed to meet the training needs of the Incident Commander Type 3 (ICT3). Focus is on the lessons of leadership and command as they relate to the ICT3 position. It is presented in participative lecture format with multiple tactical decision games for students to practice new knowledge. The seven instructional units cover Foundation Skills, Situational Awareness, Command and Control, Managing the Incident, Transitional Activities, Post-Fire Activities and a Final Simulation.	Students gain an understanding of the determinants of fire behavior through studying inputs (weather, slope, fuels, and fuel moisture). Students also learn how to interpret fire behavior outputs, documentation processes, and fire behavior briefing components. Course objectives include: List the assumptions, limitations, and appropriate uses of fire behavior prediction models. Describe how environmental factors and processes affect fire behavior predictions and safety. Define and interpret fire behavior prediction model inputs. Interpret, communicate, apply, and document wildland fire behavior and weather information.
Prerequisite(s): Qualified as Incident Commander Type 4 (ICT4) and Task Force Leader (TFLD)	Prerequisite(s): Completion of S-290 Intermediate Wildland Fire Behavior. Qualified as any single resource boss. Completion of pre-selection assessment and pre-course work

ICS-300	Intermediate ICS: ICS for Expanding Incidents	Course Description: Course is designed to enable personnel to operate efficiently using the Incident Command System (ICS) in supervisory roles on expanding or Type 3 incidents. Topics include: ICS fundamentals review, incident/event assessment & agency guidance in establishing incident objectives, Unified Command; incident resources management; planning process, demobilization, and incident transfer of command or close out. National Incident Management System (NIMS) compliant.	Required ICS-200	10/21 – 10/23
ICS-300 Refresher	Refresher: Intermediate ICS for Expanding Incidents	Course Description: This course is a refresher for individuals who have previously completed ICS-300 Intermediate Incident Command System (ICS) for the Expanding Incident. Course will review: NIMS; ICS introduction; ICS single resource; unified command; assessment; planning; resource management; demobilization; complex incidents; incident area command and multi-agency coordination.	Required ICS-300	10/25
ICS-400	Advanced ICS	Course Description: Course is designed to enable personnel to operate efficiently in the advanced application of the Incident Command System in a complex incident environment. Topics include: fundamentals review for command and general staff, major and/or complex incident/event management, Area Command, and multi-agency coordination. National Incident Management System (NIMS) compliant.	Required ICS-300	10/24 – 10/25
G-191	Incident Command System/Emergency Operations Center Interface	This course reviews ICS and EOC responsibilities and functions and depends heavily on exercises and group discussions to formulate the interface. The course provides an opportunity for participants to begin developing an interface between an Incident Management Team and EOC personnel.	None	10/24
UAS-107 Prep	Unmanned Aircraft Systems FAA Prep Course	This course will help first responders to prepare for the FAA Part 107 Exam required when flying UAS (Drones) for non-recreational purposes. The course along with an additional 10-15 hours of self-study will prepare the student for successful completion of the FAA Part 107 exam. Students are encouraged to schedule their exam as soon possible upon completion of this course.	None	10/22 – 10/23
